## Tulsa Chapter Scholarship Award

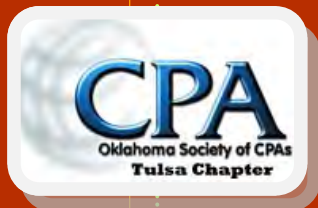

## Tulsa Drillers Night

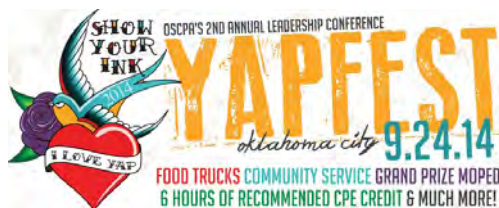
