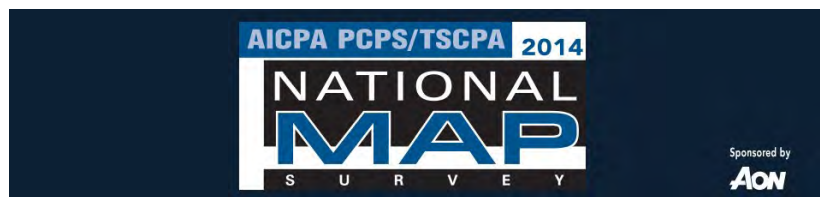
June CPE Luncheon
